This resignation from office as individual trustee ex-tends, not only to the Original Indenture of Mortgage and Deed of Trust of January 1, 1946, hereinbefore mentioned, but also to resignation from office as individual trustee under each of the now existing nine Supplements to such Original Indenture of Mort-gage and Deed of Trust, the first eight of which are executed as mortgagor under the corporate name of Oregon Washington Telephone Company, former corporate name of United Telephone Company of the Northwest, and dated, respectively, April 1, 1948, January 1, 1951, September 1, 1954, June 1, 1959, July 1, 1960, December 1, 1960, June 1, 1962 and September 1, 1964; and the ninth of which is exe-cuted under the present corporate name of United Telephone Company of the Northwest, as mortgagor, under date April 1, 1966. of the Northwest, as mortgagor, under date April 1, 1966.
