Gentlemen:

This instrument will serve to make of record to you, and to each of you, the acceptance of the undersigned to appointment by Harold A. Rogers, President of Peoples National Bank of Washington, a national banking association, formerly Peoples National Bank of Washington in Seattle, as individual trustee, successor to E. L. Blaine, Jr. resigned, appointment being made under the provisions of section 16.09 of that certain Indenture of Mortgage and Deed of Trust, dated as of January 1, 1946, made and executed by United Telephone Company of the Northwest, an Oregon corporation, under its then corporate name of Oregon Washington Telephone Company, as mortgagor, to Peoples National Bank of Washington, a national banking association, under its then corporate name of Peoples National Bank of Washington in Seattle, as corporate trustee, and E. L. Blaine, Jr., as individual trustee, such individual trustees being collectively referred to as mortgagee; appointment as successor trustee, as aforesaid, extending to office as trustee successor to E. L. Blaine, Jr., resigned, under the terms of the nine Supplements to the Original Indenture of Mortgage and Deed of Trust, above referred to, the first eight of which are executed as mortgagor under the corporate name of Oregon Washington Telephone Company, former corporate name of United Telephone Company of the Northwest, and dated, respectively, April 1, 1948, January 1, 1951, September 1, 1954, June 1, 1959, July 1, 1960, December 1, 1960, June 1, 1962 and September 1, 1964; and the ninth of which is executed under the present corporate name of United Telephone Company of the Northwest, as mortgagor, under date of April 1, 1966; and all future Supplements to such Original Indenture of Mortgage and Deed of Trust, dated as of January 1, 1946.

This acceptance of appointment is promulgated and made of record under the provisions of section 16.10 of the Original Indenture of Mortgage and Deed of Trust of January 1, 1946, above referred to.
