ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS, that I, E. L. BLAINE, JR., individual trustee retired from office by resignation as individual trustee under the terms of that certain Indenture of Mortgage and Deed of Trust made and executed as of January 1, 1946 by United Telephone Company of the Northwest, an Oregon corporation, under its then corporate name of Oregon Washington Telephone Company, as mortgagor, to Peoples National Bank of Washington, a national banking association, under its then corporate name of Peoples National Bank of Washington in Seattle, as corporate trustee, and to me, E. L. Blaine, Jr., as individual trustee, do, conformably to the provisions of section 16.10 of the instrument aforesaid, assign, transfer, convey and set over unto ROBERT G. PERRY, in his capacity as successor individual trustee to me under the terms of such instrument, all estates, properties, rights, powers and trusts residing in me in my capacity as individual trustee (now resigned) under the terms of said Indenture of Mortgage and Deed of Trust of January 1, 1946, and under each of the nine existing Supplements thereto, the first eight of which are executed as mortgagor under the corporate name of Oregon Washington Telephone Company, former corporate name of United Telephone Company of the Northwest, and dated, respectively, April 1, 1948, January 1, 1951, September 1, 1954, June 1, 1959, July 1, 1960, December 1, 1960, June 1, 1962 and September 1, 1964; and the ninth of which is executed under the present corporate name of United Telephone Company of the Northwest, as mortgagor, under date April 1, 1966.

TO HAVE AND TO HOLD the estates, properties, rights, powers and trusts aforesaid unto the said ROBERT G. PERRY, as successor to me as individual trustee under the terms of the said Indenture of Mortgage and Deed of Trust of January 1, 1946.

IN TESTIMONY WHEREOF, I have hereunto set my hand in my capacity as individual trustee resigned under the terms of the Indenture of Mortgage and Deed of Trust of January 1, 1946, hereinbefore referred to, on this, the 22 day of April, 1967.


