Reference is made to that certain
trust deed made, executed and delivered

and WANDA PONTRELLI, h & w, and
THOMAS GSA and FLORA GSA, h & w,
as grantor to WILLIAM GANONG, h & w,
as trustee, to secure certain sums due in
favor of FIRST FEDERAL SAVINGS
AND LOAN ASSOCIATION OF KLAMATH
FALLS, as beneficiary, dated
February 22, 1963, recorded February 27,
