RIGHT OF WAY EASEMENT
(INDIVIDUAL)

For value received the undersigned Grantor S. Otto H. Schaffner and Margaret Schaffner husband and wife do hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, the Grantee, an easement or right of way for an electric transmission and distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and the right to place all or any part of such line in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described real property in Blamont County, State of Ore to-wit:

A power line running northerly from the Cross Road adjacent to and more or less parallel to the North South 1/4 line of the SW 1/4 of section 3 Township 40S Range 9E W.17. and extending one span into the SE 1/4, SE 1/4 SW 1/4 NW 1/4 of section 3 Township 40S Range 9E W.17. and adjacent to the north west corner of an existing bridge and the north side of an existing drain ditch.

Together with the right of ingress and egress over the adjacent lands of the Grantor S for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.
