husband and wife do hereby grant to PACIFIC POWER & LIGHT COMPANY, a
 corporation, its successors and assigns, the Grantee, an easement or right of way for an electric transmission and
 distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph
 wires, towers, poles, props, guys and other supports and the right to place all or any part of such line in underground
 conduits) at or near the location and along the general course now located and staked out by the Grantee over, across
 and upon the following described real property in Klamath County, State of Oregon to-wit:

A power line as staked in the field, starting in the
 NE¹SW⁴NE⁴ and running more or less through the center
 of the NW⁴NE⁴ of section 33 T36S R7E W.M. and
 running more or less through the center of the SW¹SE⁴
 of section 28 and into the SW⁴NW⁴SE⁴ of section 28
 T36S R7E W.M. Line is running in a northerly direction
 from point of take off and more or less paralleling
 an existing road.

Together with the right of ingress and egress over the adjacent lands of the Grantor for the purpose of
 constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising
 other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.

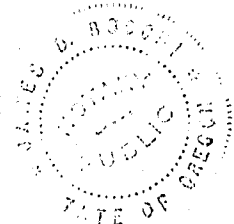
