Together with the right of ingress and egress over the adjacent lands of the Grantor I for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.

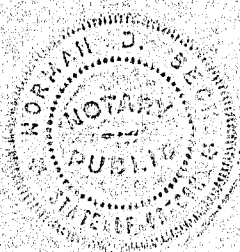
All such rights hereunder shall cease if and when such line shall have been abandoned.
