 distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph
 wires, towers, poles, props, guys and other supports and the right to place all or any part of such line in underground
 conduits) at or near the location and along the general course now located and staked out by the Grantee over, across
 and upon the following described real property in Klamath County, State of Oregon to-wit:

An existing pole line extending west from Harpold Rd along
 an existing fence to the east edge of a Shasta View
 Irrigation District ditch. Located in the NE¹ NE⁴ of Section 6
 T41S R12E W.M. more or less paralleling the North section
 line of section 6

Together with the right of ingress and egress over the adjacent lands of the Grantor S for the purpose of
 constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising
 other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.

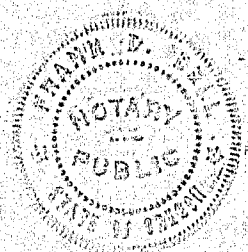
