An existing pole line extending west from Harpold Rd along an existing fence to the east edge of a Shasta View Irrigation District ditch. Located in the SE⁴ SE⁴ of Section 31 T40S R12E W.17. more or less paralleling the south section line of Section 31

Together with the right of ingress and egress over the adjacent lands of the Grantor S for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.

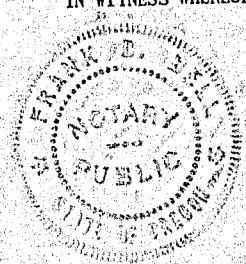
