15 This cause having come on before the Court for trial on
16 July 16, 1964, plaintiff appearing in person and by his attorney,
17 Forrest E. Cooper, Defendant State of Oregon appearing by its
18 attorney, Chick Chaloupka, District Attorney for Lake County,
19 Oregon, and an order of default having been made and entered
20 against the defendant prior to said trial for want of an
21 appearance, and the Court having heard the testimony of the
22 plaintiff and having made and entered its findings of fact
23 and conclusions of law herein, and the Court now being advised
24 in the premises;

25 IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED
26 1. That the bonds of matrimony heretofore existing between
27 plaintiff and defendant, be, and the same are hereby forever
28 dissolved and held for naught;

29 2. It is further decreed that plaintiff be, and he is
30 hereby awarded the continued custody of the two minor children
31 of the parties, to wit: a son David George Fullerton, born
32 May 9, 1951; and a son Daniel Mark Fullerton, born April 19,
1958, until the further order of the Court;

3. The plaintiff is hereby awarded all of the right,
title, estate, lien and interest of the defendant in and to the
following described tracts of real property situated in Klamath

1 and Lake Counties, Oregon, to wit:

2 Lot 9 in Block 2, North Bly,
3 Klamath County, Oregon, as platted and recorded.

4 Beginning at a point on the South line of
5 the Southeast quarter of the Northwest
6 Quarter of Section 2 Township 39 South,
7 Range 9 E.W.M., which point is
8 North 88° 57' East 330.02 feet from the
9 Southwest corner of the Southeast Quarter of
10 the Northwest Quarter thence North 0° 35' West
11 963.8 feet to the true point of beginning,
12 thence North 0° 35' West 75 feet, thence South 89°
13 25' West 135 feet, thence South 0° 35' East 75
14 feet, thence North 89° 25' East 135 feet to the
15 point of beginning, AND BEING DESIGNATED AS
16 2057 Gettle Street, Klamath Falls, Klamath County,
17 Oregon.

18 Beginning at the Southeast corner of Lot 6, Block
19 3 of Watson's First Addition to the Town of Lake-
20 view, Oregon, thence running North along the East
21 line of Lots 5 and 6 of said Block 3, a distance of
22 105 feet; thence running West and parallel with
23 the South line of said Lot 6, a distance of 62.5
24 feet; thence running South and parallel with the
25 East line of Lots 5 & 6 in Block 3, 105 feet to the
26 South line of said Lot 6; thence running East
27 along the South line of Lot 6 to the point of
28 beginning, Lake County, Oregon.

29 and the defendant is hereby commanded to execute and deliver
30 unto the plaintiff a deed of conveyance conveying all of her
31 right, title and interest in and to said three tracts unto
32 the plaintiff and if she shall neglect, fail or refuse to
33 deliver such a conveyance within 20 days from the date of this
34 decree, this Decree shall stand in lieu of said conveyance.

35 4. It is further decreed that the plaintiff shall pay
36 unto whomsoever shall be entitled to receive the same, all
37 existing obligations heretofore jointly assumed by the parties
38 for the purpose of acquiring or improving the above described
39 tracts of real property and the Court does hereby place upon
40 the plaintiff the responsibility and liability of saving the
41 defendant harmless upon any such indebtedness existing as of the
42 date of this decree.

43 5. It is further decreed that as between the parties the

1 plaintiff shall bear the full responsibility and obligation
2 of the support and education of the minor children of the
3 parties during their minority subject to the continuing
4 jurisdiction of this Court to require both plaintiff and
5 defendant, if need be, to discharge their parental obligations
6 to the end that said children shall be adequately cared for.

7 6. It is further decreed that the defendant shall have,
8 and she is hereby granted the right to visit one or both of the
9 minor children of the parties at the residence of the plaintiff
10 at all reasonable times and to have said children and each of
11 them share her residence with her for the purposes of visitation
12 for a period of time not to exceed six weeks during each summer
13 school vacation and she shall have the right to have them share
14 her home with her for purposes of visitation during the spring
15 and winter school vacation periods;

16 7. It is further decreed that the Social Security Numbers
17 and addresses of plaintiff and defendant are as follows:
18 Plaintiff, George W. Fullerton, 542-16-2142; 928 Center
19 Street, Lakeview, Oregon; Norma Louise Fullerton, 235-73-0012,

21 8. It is further decreed that neither party to this
22 decree shall enter into a marriage contract with any other
23 party for a period of six months immediately subsequent to the
24 date of this decree. The parties to this suit are not hereby
25 barred from again marrying each other;

26 9. It is further decreed that the Clerk of the Court
27 supply each of the parties with a certified copy of this decree,
28 free of charge.
