A tract of land situated in the NE 1/4 SW 1/4 of Section 10, T 36 S, R 6 E.W.M., Klamath County, Oregon, more particularly described as follows:

Beginning at the brass cap monument on the NE corner of "Frontier Tracts", said point being the Center 1/4 corner of said section 10; thence S 0°36' W along the East line of "Frontier Tracts" a distance of 61.1 feet to an iron pin; thence S 89°24' W a distance of 100.0 feet to an iron pin; thence N 0°36' E a distance of 61.0 feet to an iron pin on the North line of "Frontier Tracts"; thence N 89°17' E along the North line of "Frontier Tracts" a distance of 100.0 feet, more or less, to the point of beginning.

against the lawful claims and demands of all persons whomsoever.




