Beginning at a point on the South line of the North one-half of Section 4, Township 34 S. R. 7 E. W. M., which is the intersection of said South line with the Easterly water line of Spring Creek and which point of beginning is 864 feet more or less, West of the quarter corner common to Sections 3 and 4 of said Township and Range; thence East along the South line of the North one-half of said Section 4, a distance of 203 feet; more or less, to a point marked by an iron pipe; thence North 300 feet; thence West 135 feet to the edge of the water at the Easterly bank of Spring Creek; thence Southerly along the water's edge to the point of beginning, being a portion of the SE 1/4 of Section 4, Township 34 S.
