Klamath County, Oregon

ORDER OF VACATION

WHEREAS, on the 19th day of April, 1967 a petition was received
from one (1) property owner requesting that a portion of Lombard Drive,
located in First Addition to Cypress Villa, be vacated, and

WHEREAS, on April 26, 1967 duly prepared notices of the hearing
on the above entitled matter were posted on the bulletin board at the
County Courthouse and in the vicinity of said street, and published in the
Herald & News, a newspaper of general circulation in Klamath County, Oregon
giving notice of a public hearing to be held at 10:30 A. M. on May 31, 1967
in the Board of Commissioner's Hearing Room, and

WHEREAS, this public hearing was held in the Hearing Room and after
testimony from the City-County Planning Department opposing the proposed vaca-
tion, the Board of Commissioners continued the hearing to June 14, 1967, and

WHEREAS, this hearing was held and the Commissioners did consider
the objection expressed by the City-County Planning Department, and

WHEREAS, it was the decision of the Board of Commissioners to
grant the vacation request in part and amended the street vacation;

NOW THEREFORE IT IS HEREBY ORDERED that a portion of Lombard Drive
located in First Addition to Cypress Villa described as follows, to-wit:

Beginning at a point which lies northwesterly along a
4014.72 foot radius curve to the right a distance of
70.00 feet from the southeast corner of Lot 1, Block 5
of said First Addition to Cypress Villa; thence N.61°37'
18" E. a distance of 60.00 feet to the United States
Bureau of Reclamation "A" Canal right-of-way; thence
following said right-of-way along a 3954.72 foot radius
curve to the right a distance of 15.75 feet; thence
following said right-of-way N.28°09'00" W. a distance
of 174.00 feet; thence following said right-of-way
along a 437.96 foot radius curve to the left a distance
of 90.19 feet; thence S.00°12'00" E. a distance of 108.25
feet; thence S.28°09'00" E. a distance of 167.96 feet;
thence along a 4014.72 foot radius curve to the left a
distance of 16.02 feet to the point of beginning.
