KNOW ALL MEN BY THESE PRESENTS, That

H. C. HEAD & CORA F. HEAD, husband and wife,

hereinafter called Grantors, in consideration of

TEN AND NO/100 - - - - - (\$10.00) - - - - - DOLLARS

and other good and valuable consideration

to Grantors paid, receipt of which is hereby acknowledged, do hereby grant,

bargain, sell and convey to GLEN B. HEAD & VERNA A. HEAD, husband and wife,

hereinafter called Trustees, their heirs, successors and assigns all of that

certain real property with the tenements, hereditaments and appurtenances there-

unto belonging or in anywise appertaining, situated in the County of Klamath,

State of Oregon, described as follows, to-wit:

All of Lots Fifteen (15) and Sixteen (16), Block Forty-six (46), Hillside Addition to the City of Klamath Falls, Oregon, and

The East One Hundred Five (105) feet of Lots Ten (10), Eleven (11) and Twelve (12), Block Forty-seven (47), Hillside Addition to the City of Klamath Falls, Oregon.

To Have and to Hold the same in trust for the use and benefit of Grantors during their lifetime. On the death of the survivor of Grantors, this trust shall terminate and the above-described real property shall vest in Trustees, their heirs, successors and assigns in fee simple.

The Grantors, or either of them during their lifetime, shall have the right at any time to revoke this trust, in whole or in part, by an instrument in writing executed and acknowledged by Grantors, or either of them, and delivered to the Trustees; and shall further have the right to manage and control the real estate conveyed hereunder during the lifetime of said Grantors, or either of them.

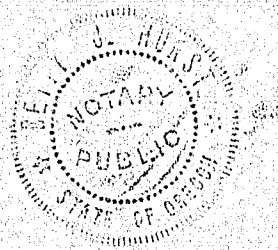

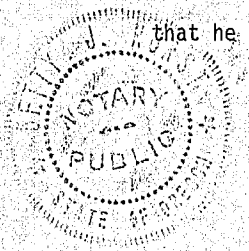
