This matter coming on at this time to be heard, this being the time heretofore set for the trial of this cause, plaintiff appearing in person, by his attorney, A. C. Stadter, District Attorney for Deschutes County, and defendant appearing not, but being in default, which default has been heretofore entered,

WHEREUPON Plaintiff, after being first duly sworn, went upon the stand and gave testimony in support of the allegations of his complaint, and the court having duly considered the same finds that the evidence is competent evidence, and that the plaintiff is entitled to the relief prayed for in his complaint,

IT IS, THEREFORE, HEREBY ORDERED, ADJUDGED and DECREED that plaintiff be and he is hereby given a decree of divorce of and from the defendant.

IT IS FURTHER ORDERED and DECREED that the plaintiff be and he is hereby declared to be the owner of the following described property, real and personal:

All that portion of the North Half of the Southwest Quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$) and the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) in Section 25, Township 23 South, Range 9, EWM lying East of Highway No. 97, save and except that portion thereof heretofore taken by the State of Oregon for highway right of way

together with all personal property located therein and thereon to the exclusion of any right, title and interest therein and thereto on the party of the defendant.
