DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated May 23, 1966, executed and delivered by E. G. Gienger and Ora M. Gienger, husband and wife, as grantor and recorded on May 25, 1966, in book M-66 at page 5518 of the Mortgage Records of Klamath County, Oregon, conveying real property situated in said county described as follows:
