Tedrick aka Eleanor I. Duncan the Vendor under said contract of sale, was and is the owner of record of the real estate described above. Claimant commenced his performance of said contract January 15, 1967 and abandoned his said contract on August 22,1967 the abandonment was due to the apparent intention of the vendor owner to foreclose the centract of sale herein above mentioned.

At the time Claimant entered into said contract and at the time Claimant commenced the said work and the furnishing of said material, Eleanor L.

Duncan was the owner of said land and improvements and the statutory person by whom Claimant was employed and to whom Claimant' furnished materials; at all times herein mentioned, the said owner had knowledge of the remodeling construction of said improvement; on the date hereof Eleanor L. Tedrick aka Eleanor L. Duncan is the custor or reputed owner of said land and improvements.

The contract price and reasonable value of said labor and materials furnished for use and used in connection with said construction was and is \$2,917.80 and there is now due and owing claimant for the said materials so furnished and the labor performed, after deducting all just credits and offsets, the sum of \$2,917.80.
