WARRANTY DEED

A parcel of land lying in the S¹₂SE¹₂NE¹₂ of Section 7, Township 39 South, Range 9 East, W.M., Klamath County, Oregon; the said parcel being that portion of said S¹₂SE¹₂NE¹₂, lying West of that property described in that deed to Gertrude Cleve, recorded in Book 102, Page 16; Northwesterly of that property described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 290, Page 120 both of Klamath County Record of Deeds and included in a strip of land variable in width, lying on the Northwesterly side of the center line of a frontage road, which center line is described as follows:

Beginning at Engineer's center line Station "FR" 221+00, said station being 1015.79 feet South and 39.74 feet West of the Northeast corner of said Section 7; thence South 28° 36' 30" West, 262.47 feet; thence on a 572.96 foot radius curve right (the long chord of which bears South 32° 39' 15" West) 80.92 feet; thence South 36° 42' West, 1228.48 feet; thence on a 409.26 foot radius curve right (the long chord of which bears South 50° 41' 15" West) 199.82 feet; thence South 64° 40' 30" West, 200.71 feet; thence on a 65 foot radius curve left (the long chord of which bears South 26° 33' 15" West) 86.49 feet to Engineer's center line Station "FR" 241+58.89.

ALSO that portion of said $\rm S^1_3SE^1_NE^1_4$ lying Northwesterly of said State of Oregon property and Westerly of said Cleve property.

Bearings used herein are based upon the Oregon Co-ordinate System, South Zone.

The parcel of land to which this description applies contains 2.2 acres, more or less.

As a part of the consideration hereinabove stated, there is also bargained, sold, conveyed and relinquished to the Grantee all existing, future or potential common law or statutory abutter's easements of access between all of the Grantor's remaining real property and the parcel hereinabove described.

Grantee shall either construct a public frontage road or provide some other access road on the Northwesterly side of the highway, and the Grantor, her heirs and assigns, shall be entitled to reasonable access to the said road for any purpose, upon application filed with the State pursuant to applicable statutes and regulations. Said road shall be connected to the main highway or to other public ways only at such places as the Grantee may select.

It is expressly intended that the covenants, burdens, restrictions and reservations contained herein shall run with the land and shall forever bind the Grantor, her heirs and assigns.
