For value received the undersigned Grantor L. V. Howard & Waive Howard
Husband & Wife do hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, the Grantee, an easement or right of way for an electric transmission and distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and the right to place all or any part of such line in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described real property in Klamath County, State of Oregon to-wit:

A pole line extending more or less south west from the Keno Warden Road along an existing fence line in the SE⁴ NE⁴ SE⁴ of Section 7 Township 40S Range 8E W. 17. Line as staked will turn more or less west in the SW⁴ SE⁴ NE⁴ SE⁴ of section 7 Township 40S Range 8E W. 17. and extend into the SW⁴ NE⁴ SE⁴ of section 7 Township 40S Range 8E W. 17. more or less paralleling an existing private road which is about 100 feet to the North.

Together with the right of ingress and egress over the adjacent lands of the Grantor L for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.
