To invest and reinvest, vary and change any or all of the trust investments hereunder without restriction to investments authorized by law for trustees; to sell any and all property conveyed to them by the Donors, and invest and reinvest the proceeds, all as they may deem advisable in their sole discretion. No purchaser of said properties or investments, or any part thereof, shall be required to 30 see to the application of any purchase moneys paid therefor.

The donors reserve the right to add to the principal of this trust from time
