RIGHT OF WAY EASEMENT

For value received the undersigned Grantors do hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, the Grantee, an easement or right of way for an electric distribution line of one or more wires and all necessary or desirable appurtenances (including substation, towers, poles, props, guys and other supports and the right to place all or any part of underground) at or near the location now located and staked out by the Grantee over, across and upon the following described real property in Klamath County, State of Oregon to wit:

> A portion of the West one half of the West one half of the Northwest Quarter of the Southeast Quarter of Section 28, Township 34 South, Range 7 East, W.M. lying North of road.

Substation to be constructed on a tract of land 20 feet by 40 feet as shown on Exhibit "A" attached hereto and part hereof.

Together with the right of ingress and egress over the adjacent lands of the Grantors for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights

The Grantee shall pay to the Grantors reasonable compensation for any damage caused by Grantee, or its agents, to any property or crops (growing or to be grown) on the above described real property, arising out of the construction, reconstruction, operation or maintenance of said transmission and distribution line.

All such rights hereunder shall cease if and when such line shall have been abandoned.
