8 County Road Right of Way being more particularly described as follows:

9 Beginning at the Northeast corner of said Section 19, Twp. 39 S., R.

thence, West along the Section Line between said Section 19 and Section  
11 18 to the Northwest corner of said NE $\frac{1}{4}$  of said Section 19;  
thence, South on the center Section Line of said Section 19 a distance  
12 of 30 feet;  
thence, East on a line parallel to and 30 feet distant from said Section  
13 Line between Sections 19 and 18 to the East Section Line of said Section  
14 19;  
thence, North along said East Section Line a distance of 30 feet to the  
point of beginning of this description.
