

ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS:

That TRUMAN L. WALKER and NATALIE H. WALKER, husband and wife, hereinafter referred to as Assignors, in consideration of Ten Dollars and other valuable considerations, to them in hand paid, and in further consideration of a complete release of all right, title and interest in and to one certain Federal Insurance check number 89,044,513, and the funds said check represents, said check being received for crop losses on partnership property, by DONALD M. PHILLIPS and MARIAN A. PHILLIPS, husband and wife, hereinafter referred to as Assignees, do, by these presents, sell, assign, transfer and set over unto Assignees all of their right, title and interest (being an undivided one half interest) in and to that certain contract dated June 14, 1965, wherein Charles M. Ohles and Amy Edith Ohles, husband and wife, agreed to sell, and Truman L. Walker and Natalie H. Walker, husband and wife, and Donald M. Phillips and Marian A. Phillips, husband and wife, agreed to buy the following described real property situate in Klamath County, Oregon, to-wit:

The SE<sup>1</sup>t of SW<sup>1</sup> and the SW<sup>1</sup>t of SE<sup>1</sup>t of Section 1, and the NW<sup>1</sup>t of NE<sup>1</sup>t of Section 12, in Township 39 South, Range 8, E.W.M., saving and excepting therefrom the following described portions:

(1) A strip of land 15 feet in width off the West side of the SE<sup>1</sup>t of SW<sup>1</sup>t of said Section 1.

(2) Parcel of land conveyed to Robert A. Yantis and Dorothy B. Yantis, by deed recorded on page 141 of Vol. 209 of Deeds, records of Klamath County, Oregon, containing 10 acres, more or less.

(3) Parcel of land conveyed to Jessie Totten by deed recorded on page 143 of Vol. 209 of Deeds, records of Klamath County, Oregon, and containing 5 acres, more or less.

And Assignors further, in consideration of the foregoing, bargain, sell and convey to Assignees, all of their right, title and interest in said real property, subject to the terms of said contract, which said contract Assignees do hereby assume and agree to pay and perform according to its terms as the same come due and to hold Assignors harmless therefrom.
