ORDINANCE NO. 262

WHEREAS, a Petition having been filed on the 8th day of January, 1968
vacating the following described real property:

The South 20 ft. of Chinchalo St. between Baker St. and
the East bank of the Williamson River;

and

WHEREAS, the hearing was held on the 23rd day of January, 1968 and
no objections have been filed thereto,

THE CITY OF CHILOQUIN DOES ORDAIN AS FOLLOWS:

Section 1.

That the following described real property, to-wit:

The South 20 ft. of Chinchalo St. between Baker St. and
the East bank of the Williamson River

be and all thereof is hereby vacated.

Section 2.

The immediate enactment of this Ordinance being deemed necessary for
the preservation of the public peace, safety and welfare, an emergency is
declared to exist and this Ordinance shall be in full force and effect from
and after its passage by a three-fourths "aye" and "nay" vote of the Common
Council and its approval by the Mayor.

Passed by the Common Council of the City of Chiloquin, Oregon, this
13 day of February, 1968.
