## NOTE AND MORTGAGE

I promise to pay to the STATE OF OREGON Seventeen Thousand Six Hundred and no/100 - - Dollars (s. 17,600.00 - - -), with interest from the date of initial disbursement by the State of Oregon, at the rate of four percent per annum, principal and interest to be paid in lawful money of the United States at the office of the Director of Veterans' Affairs in Salem, Oregon, as follows:

\$ 96.00 --- on or before May 1, 1968 --- -- and \$ 96.00 on the 1st of each month --- thereafter, plus one-twelfth of -- the ad valorem taxes for each successive year on the premises described in the mortgage, and continuing until the full amount of the principal, interest and advances shall be fully paid, such payments to be applied first as interest on the unpaid principal, the remainder on the principal.

The due date of the last payment shall be on or before April 1, 1992.

In the event of transfer of ownership of the premises or any part thereot, to anyone other than a qualified veteran under ORS 407.010 to 407.210 who assumes the indebtedness in his own right. I will continue to be liable for payment and if transferred to a person not entitled to a 4% interest rate, the balance shall draw interest as prescribed by ORS 407.070 from date of such transfer.

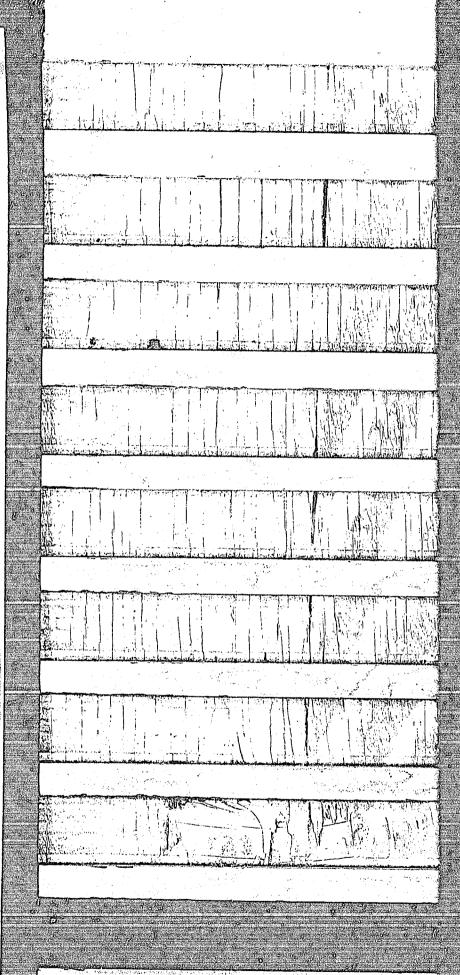

MORTGAGOR FURTHER COVENANTS AND AGREES:

- 1. To pay all debts and moneys secured hereby:
- permit the cutting or removal of any timber except for his own domestic use; not to commit or suffer any waste;
- 4. Not to permit the use of the premises for any objectionable or unlawful purpose;
- 5. Not to permit any tax, assessment, lien, or encumbrance to exist at any time:

To promptly notify mortgagee in writting of a transfer of ownership of the premises or any part or interest in same, and to furnish a copy of the instrument of transfer to the nortgagee; any purchaser shall assume the indebtedness, and purchasers not entitled to a loan or 4°, interest rate under ORS 1070 or 1022 shall pay interest as prescribed by ORS 407.070 on all payments due from the date of transfer; in all other respects this mortgage shall remain in full force and effect; no instrument of transfer shall be valid unless same contains a covenant of the grantee whereby the grantee assumes the covenants of this mortgage and agrees to pay the indebtedness secured by same.

The mortgagee may, at his option, in case of default of the mortgagor, perform same in whole or in part and all expenditures made of doing including the employment of an attorney to secure compliance with the terms of the mortgage or the note shall draw rest at the rate provided in the note and all such expenditures shall be immediately repayable by the mortgagor without demand shall be secured by this mortgage.
