
SHERIFF'S DEED

WITNESSETH:

That the said party of the first part, by virtue of an execution and order of sale duly issued out of the Circuit Court of the State of Oregon, for the County of Klamath, on the 18th day of October, 1967, on a judgment and decree theretofore duly taken in said Court, in a suit wherein Pacific First Federal Savings and Loan Association was plaintiff, and Roy W. Johns and Ruth E. Johns, husband and wife (record owners), and E. J. Shipsey and Carter-Jones Collection Service, Inc., an Oregon corporation, were defendants, for the foreclosure of a mortgage upon the property hereinafter described, and a sale of said property duly made on the 27th day of November, 1967, and a due confirmation of said sale on the 13th day of December, 1967, and in pursuance of the statutes in such cases made and provided, particularly ORS 23.600, and an order directing this conveyance entered in said Court and cause March 15, 1968, and for and in consideration of the sum of \$5,242.53 paid by party of the second part (\$69.53 in cash and the balance by way of satisfaction of the said judgment and decree), has granted, bargained, sold, conveyed and confirmed, and by these presents does grant, bargain, sell, convey and confirm unto the said party of the second part, and to its successors and assigns all the right, title and interest which the said defendants had on the 2nd day of April , 1962, or at any time afterwards,

or now have in or to all those certain lots, pieces or parcels of land, situate, lying and being in the said County of Klamath, State of Oregon, and more particularly described as follows, to-wit:

Beginning at a point on the North line of Tract 32, ALTAMONT SMALL FARMS, in Section 15, Township 39 South, Range 9 E.W.M., which is North 88°46' West a distance of 300 feet from the northeast corner of said Tract 32; thence South 0°11' West 322.84 feet along a line parallel to Altamont Drive to the northeasterly right of way line of the Great Northern Railway; thence North 47°57' West 140.98 feet along said right of way line; thence North 0°11' East 228.74 feet to North line of said Tract 32; thence South 88°46' East 105 feet to the point of beginning, being a portion of Tracts 32 and 31 of said Altamont Small Farms.


