

ARTICLES OF INCORPORATION OF

LATAKONIE SHORES BEACH CLUB INC.

FILED MAR 15 1968 FRANK J. HEALY CORPORATION COMMISSIONER

The undersigned, acting as incorporators under the Oregon Nonprofit Corporation Act, adopt the following Articles of Incorporations

ARTICLE I

The name of this corporation is Latakomie Shores Beach Club Inc., and its duration shall be perpetual.

ARTICLE II

The purpose for which the corporation is organized are:

- 1. To promote and assist in preserving and enhancing the esthetic values of the Latakomie Shores Subdivision area for the mutual benefit of club members and for the benefit of the public at
- 2. To provide educational, recreational and social opporlarge. tunities for the club members.
- 3. To carry out any activity designed to improve the area of the Latakomie Shores Subdivision or to be of a benefit to the club members generally.
- 4. To do anything deemed advisable by the Board of Directors which may be legally done by an Oregon Nonprofit Corporation.


ARTICLE III

The members of this corporation shall be land owners in Latakomie Shores Subdivision. A land owner shall be considered to The the record owner of land ox the grantee of an enforceable contract of sale of such land.

ARTICLE IV

Each owner or contract buyer of land, either solely held, jointly held or held in common, shall have but one vote. Each member shall have the right to cumulate his vote and to give one candidate a

number of votes equal to his vote multiplied by the number of directors to be elected, or to distribute such votes on the same principle among any number of such candidates.

ARTICLE V

Provisions for the distribution of assets on dissolution or final liquidation are:

To distribute to such organizations in Oregon that the Board of Directors believes will best carry on the nonprofit purposes of this corporation or in lieu of any such decision of the Board of Directors, then to the Klamath County Chapter of the American Red Cross.

ARTICLE VI

The address of the initial registered office of the corpora-, Oregon, and the name tion is 428 Spring Street, Klamath Falls of its initial registered agent at such address is Charles Heaton.

ARTICLE VII

The number of directors consistituting the initial Board of Directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting or until their successors are elected and shall take office aros
