- 4. Not to permit the use of the premises for any objectionable or unlawful purpose;
- 5. Not to permit any tax, assessment, lien, or encumbrance to exist at any time;
- Mortgagee is authorized to pay all real property taxes assessed against the premises and add same to the principal, each of the

- 7. To keep all buildings unceasingly insured during the term of the mortgage, against loss by fire and such other hazards in such company or companies and in such an amount as shall be satisfactory to the mortgage; to deposit with the mortgage all such policies with receipls showing payment that of all premiums; all such insurance shall be made payable to the mortgage; if deemed a debt due and shall be secured by this mortgage; may secure the insurance and the cost shall be added to the principal, closure until the period of redemption expires;
