KNOW ALL MEN BY THESE PRESENTS, That Dean J. Hall and Hazel V. Hall, husband and wife

hereinafter called the grantor, in consideration of -----Four Hundred Fifty and no/100----- Dollars

to grantor paid by Orval Keith Musgrove and Fern Marie Musgrove, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenant by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lot 6 in Block 9 of Third Addition To Winema Gardens, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to easements and rights of way of record and apparent on the land, to building and use restrictions of record, and to rules, regulations, and assessments of South Suburban Sanitary District.
