KNOW ALL MEN BY THESE PRESENTS, That FRED P. BREWER and GRACIE DEE BREWER, husband and wife, hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by PRENTISS K. PUCKETT and BETTY C. PUCKETT, husband and wife,

hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit: All that part of the SE 1/4 SW 1/4, and all that part of the SW 1/4 SE 1/4 of Section 7, Township 24 S., R. 7 E.W.M., lying Northerly and Easterly of Highway # 58, known as Willamette Highway, and, also all that part of the NW 1/4 NE 1/4 of Section 18, Township 24 S., R. 7 E.W.M., lying Northerly and Easterly of said Highway # 58, EXCEPTING that portion deeded to Frederic E. Kerns, et ux, in Deed Volume 346 at page 343, records of Klamath County, Oregon,

TO HAVE AND TO HOLD the above described and granted premises unto the said grantees, their assigns and the heirs of such survivor, forever; provided that the grantees herein do not take the title in common but with the right of survivorship, that is, that the fee shall vest absolutely in the survivor of the grantees.

And the grantor above named hereby covenants to and with the above named grantees, their heirs and assigns, that grantor is lawfully seized in fee simple of the above granted premises, that the said premises are free from all encumbrances

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 7,500.00
The whole of the above described premises is hereby conveyed to the grantees for the whole of the above described premises.

In construing this deed and where the context so requires, the singular includes the plural, the masculine includes the feminine and the neuter and, generally, all grammatical changes shall be made, assumed and implied to make the provisions hereof apply equally to corporations and to individuals.

IN WITNESS WHEREOF, the grantor has executed this instrument on the 11th day of June, 1968; if the grantor is a corporation, it has caused its corporate name to be signed and its corporate seal to be affixed hereunto by its officers duly authorized thereunto by order of its board of directors.
