I, Robert W. Straub, State Treasurer of the State of Oregon, do hereby certify that, pursuant to the Inheritance Tax Law of Oregon, no inheritance tax has been found due from the Estate of Rex E. High, deceased, who died on or about the 25th day of March, 1968.

PARCEL I:

The SW $\frac{1}{4}$ of the SW $\frac{1}{4}$, NW $\frac{1}{4}$ of SW $\frac{1}{4}$, and Lot 6 of Sec 13; S $\frac{1}{2}$ of SE $\frac{1}{4}$, SE $\frac{1}{4}$ of SW $\frac{1}{4}$ and lots 8, 9, 10 and 11 of Sec. 14, all in Twp 39 S of R 10, E of WM, (less amount heretofore deeded to U.S Govt), save and excepting the following portion of said Lot 8; Beginning at a point where the S. Poe Valley branch of the U.S.R.S. Irrigation canal crosses the W line of lot 8, Sec 14, Twp 39 S of R 10 E of WM; thence following a curved line in an E-ly direction along the N-ly line of said Irrigation canal a distance of 603 ft, more or less, to a point where the S line of the Poe Valley Public road intersects the N line of said irrigation canal, thence W-ly along the S line of said public road a distance of 550 ft to the place of beginning.

PARCEL II:

Beginning at the intersection of the Poe Valley Branch Canal with the W line of Lot 3, Sec. 14, Twp 39 S.R. 10 E.W.M. in Oregon; thence running E-ly along the N-ly line of said canal 603 ft more or less to the S line of the Poe Valley Road; thence W-ly along the S line of said road 550 ft more or less to the W-ly line of lot 8; thence S-ly to the place of beginning, Klamath County, Oregon.
