NOTICE OF LIEN CLAIM

The Department of Employment Commissioner of Oregon hereby claims a lien in the amount of \$203.80 with interest on \$142.60 at the rate of one percent per month, or fraction thereof, until paid, upon:

any and all of the real and personal property of whatsoever kind or nature belonging to the defendants, lying or being situated in Klamath County, Oregon, and in addition the personal property located in Klamath County, Oregon, and specifically described as follows:

1964 Dodge 4W, License No. EAJ922, ID No. 6542225970, Title No. 641751513

Said lien is claimed for a sum equal to unpaid taxes due and payable for the third and fourth supplemental calendar quarters of 1965, the first, second and third supplemental calendar quarters of 1966 and the third calendar quarter of 1966 in the amount of \$142.60 taxes and \$39.65 interest, with interest on \$142.60 at the rate of one percent per month, or fraction thereof, from the 31st day of May, 1968, until paid, and penalty of \$21.55 assessed under ORS 657.515 (4) and 657.662

That written demand for payment of the sum of \$155.53, then due, was made on the defendant on November 9, 1967, and defendant failed to make payment within ten days of said demand;

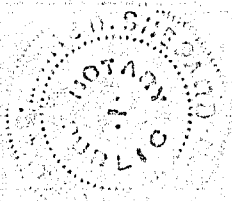
That because of the failure of defendant to make payment as required by the provisions of section 3 of ORS 657.515, defendant was in default;

These taxes are assessed under the provisions of ORS 657.681 (3) and 657.681 (1). That said monies are now due the Department of Employment Commissioner for which he claims this lien.
