2. Mortgage in favor of Southern Oregon Equipment Co., an Oregon corporation, recorded March 10, 1967, in Volume M67 at page 1716, Official Records of Klamath County, Oregon.
3. Reservations contained in that certain deed from The United States of America to Ed Gordon dated April 19, 1957, recorded November 27, 1957, in Volume 296 at page 7, which recites in part as follows:
 - (1) Right of way to the Oregon State Highway Department for the Klamath Falls-Lakeview Highway approval by John H. Edwards, Assistant Secretary of the Department of the Interior, on October 8, 1927, subject to the provisions of the act of March 3, 1901 (31 Stat. L., 1058-1084); departmental regulations thereunder and subject also to any prior valid existing right or adverse claim;
 - (2) Right of way to the California Oregon Power Company for an electric transmission line approved May 11, 1931, by Jos. M. Dixon, First Assistant Secretary of the Department of the Interior pursuant to the provisions of the act of March 4, 1911 (36 Stat. 1253), and the regulations thereunder;
 - (3) Right of Way to Oregon California and Eastern Railroad Company for a railroad approved by Jos. M. Dixon, First Assistant Secretary of the Department of the Interior, on October 26, 1931, subject to the provisions of the act of March 2, 1899 (30 Stat. L., 990) as amended by the act of June 21, 1906 (34 Stat. L., 325-330), and section 16 of the act of June 25, 1910 (36 Stat. L., 855-9); departmental regulations thereunder; subject to the terms, conditions, and covenants of stipulations executed by the applicant company dated April 15, 1929, and September 30, 1931, respectively; and subject also to any prior, valid, existing right or adverse claim. All subsurface rights, except water, are hereby reserved, in trust, for the heirs of Frank Baker, deceased Klamath allottee no. 1587.
