HAWKINS, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs and assigns, all of the following real property, with the tenements, hereditaments and appurtenances situated in the County of Klamath, State of Oregon, bounded and described as follows, to-wit:

An undivided 1/12th interest in the following real property: Beginning at a point on the West bank of Wood River where the South boundry of the land heretofore conveyed by Abner Weed et ux to George W. Loosley by deed recorded in Vol. 31 of Deeds, page 81, records of Klamath County, Oregon, intersects the said West bank of Wood River; thence West 470 feet; thence South 96 feet; thence South 19 05!
