for the consideration hereinafter stated, does hereby remise, release and quitclaim unto **Gordon David**.....

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A portion of Lot 2, Section 3 Township 35 South, Range 7 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point on the North boundary of Section 3 of the above named Township and Range, which point is West 1320 feet from the Northeast corner of said Section 3. Said point being marked with a 1 inch iron pin and being in the Northeast corner of Lot 2 of Section 3, the initial point of the survey of the City of Chiloquin and the initial point of the survey of South Chiloquin, and addition to the City of Chiloquin; thence

South 0°16' East along the common boundary of Lot 2 and South Chiloquin Addition, a distance of 238.0 feet, more or less, to the true point of beginning, which is the Northeast corner of Lot 15, Block 1 of said South Chiloquin Addition; thence

West along the North boundary of said Lot 15, a distance of 87.0 feet, more or less, to a point on the Northerly right of way boundary of the Southern Pacific Railroad Company's Otey Spur; thence

North 53°36' West along the said Railroad right of way a distance of 126.39 feet, to a point; thence

East 188.73 feet, more or less, to a point on the East boundary of said South Chiloquin Addition; thence

South 0°16' East along said boundary, a distance of 75.0 feet to the point of beginning, being a portion of Lot 16, Block 1, SOUTH CHILLOQUIN.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.
