SHERIFF'S DEED ON MORTGAGE FORECLOSURE

THIS INDENTURE, Made this 5th day of December, 1968, by
and between J. M. BRITTON, Sheriff of Klamath County, Oregon, herein-
after called the grantor, and OREGON MUTUAL SAVINGS BANK, an Oregon
corporation, hereinafter called the grantee;

W I T N E S S E T H:

RECITALS: In a suit in the Circuit Court of the State of Oregon
for Klamath County, bearing Register Number 67-236E, in which OREGON
MUTUAL SAVINGS BANK, a corporation, was plaintiff, and ROBERT E. GAR-
RISON, aka ROBERT EARL GARRISON, TERRI GARRISON, aka CHARLENE FRANCES
GARRISON, GLENN D. RAMIREZ, D. L. HOOTS, and FIRST FEDERAL SAVINGS
AND LOAN ASSOCIATION OF KLAMATH FALLS, a corporation, were defendants,
a judgment was entered and filed on the 25th day of September, 1967,
for the foreclosure of a mortgage on the real property described be-
low; following the entry of said judgment, a writ of execution direct-
ing the sale of said real property was issued out of said court, pur-
suant to which and on the 13th day of November, 1967, the said real
property was sold, subject to redemption, in the manner provided by
law, for the sum of \$30,832.06 to OREGON MUTUAL SAVINGS BANK, who was
the highest and best bidder and that being the highest and best sum
bid therefor; at the time of said sale the said purchaser paid the
amount bid for said property to the grantor; at said sale a certifi-
cate of sale as required by law was duly executed and delivered to
the said purchaser; upon due return of said sale on said execution,
the said sale was duly confirmed on the 29th day of November, 1967,
said order of confirmation having been entered in volume M67
at page 7050 of the journal of said court, to which reference
now is made.

The said real property has not been redeemed from such sale and
the time for so doing has now expired; the grantee herein is the owner
and holder of said certificate of sale.

NOW, THEREFORE, in view of the premises, in order to complete
said sale pursuant to law and in consideration of the sum paid for
said real property at said sale, the grantor has granted, bargained,
sold and conveyed and by these presents does grant, bargain, sell
and convey unto the grantee, its successors-in-interest and assigns,
that certain real property situated in Klamath County, Oregon, de-
scribed as follows, to-wit:

A tract of land situated in the SE^{1/4}NE^{1/4} of Section 3, Town-
ship 39 South, Range 9 East of the Willamette Meridian,
Klamath County, Oregon, more particularly described as
follows:

Beginning at the intersection of the North line of Miller
Avenue and the East line of Crest St. as shown on the offi-
cial plat of Balsiger Tracts, Klamath County, Oregon. Thence,
East along said North line of Miller Ave. a distance of 150
feet; thence, North parallel to said East line of Crest St.
a distance of 75 feet; thence West parallel to said North
line of Miller Ave. a distance of 150 feet to said East line
of Crest St.; thence South on said East line of Crest St.
a distance of 75 feet to the point of beginning, said Tract
being portions of vacated Lots 31, 32, 33 and 34 of said
Balsiger Tracts;

together with all of the tenements, hereditaments and appurtenances
thereunto belonging or in anywise appertaining and all of the interest
of the defendants and each of them in and to said real property;
