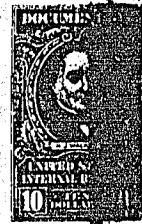

1 THIS INDENTURE WITNESSETH, That Eli M. Butler and Peggy L. Butler, husband
2 and wife, and Harold Daniels and Phyllis L. Daniels, his wife, hereinafter known
3 as Grantors, for and in consideration of the sum of Ten Dollars to them paid have
4 bargained and sold, and by these presents do grant, bargain, sell and convey unto
5 Robert J. Krusmark and Wilma J. Krusmark, husband and wife, and James R. Walker
6 and Mary L. Walker, husband and wife, their heirs and assigns, the following
7 described premises situated in Klamath County, Oregon, to-wit:

8 Beginning at a point on the north right of way line of the county road known
9 as Hilyard Avenue, 30 feet North and at right angles from the center line
10 of Hilyard Avenue, this point of beginning being North 0°04' West a distance
11 of 30 feet and North 89°56' East a distance of 514.1 feet from the iron axle
12 which marks the quarter corner common to Sections 1 and 12 in Township 39
13 South, Range 9 E.W.M., thence North 29°06' East and along the line of prop-
14 erty conveyed to Edward D. and Ester V. Ault by deed recorded in Vol. 252,
15 page 435, Klamath County Deed Records, a distance of 552.6 feet, more or less,
16 to the Southerly right of way line of the Dalles-California State Highway;
17 thence North 46°09' West along said right of way line a distance of 334.2 feet
18 to a point; thence South 43°51' West a distance of 405.8 feet to a point;
19 thence South 3°24' East a distance of 415 feet, more or less, to the North
20 line of said Hilyard Avenue; thence North 89°56' East along said North line
21 of Hilyard Avenue a distance of 230 feet to the point of beginning, and con-
22 taining 5.30 acres, more or less;

23 SUBJECT TO: Contract and/or lien for irrigation and/or drainage; easements
24 and rights of way of record and those apparent on the land, if any; and to
25 mortgage to First Federal Savings and Loan Association of Klamath Falls re-
26 corded April 25, 1957 in Vol. 176 at page 270 of Klamath County, Oregon Mortgage
27 Records, which mortgage grantee herein said agree to pay and perform according
28 to its terms as the same becomes due and to hold Grantors harmless therefrom.

29 TO HAVE AND TO HOLD the said premises, with their appurtenances unto the said
30 Grantees, their heirs and assigns, forever, as follows:

31 An undivided one-half interest therein to said Robert J. Krusmark and
32 Wilma J. Krusmark, husband and wife, as tenants by the entirety; and

33 An undivided one-half interest therein to said James R. Walker and Mary
34 L. Walker, husband and wife, as tenants by the entirety.

35 And the said Grantors do hereby covenant to and with said grantees, their
36 heirs and assigns, that they are the owners in fee simple of said premises; that
37 they are free from all incumbrances, except those above set forth, and that they
38 will warrant and defend the same from all lawful claims whatsoever, except those
39 above set forth.
