THIS IS THE LAST WILL AND TESTAMENT of me, EDNA E. WORDEN, of Klamath County, Oregon.

FIRST: I revoke all other and former wills by me heretofore made.

SECOND: I nominate, constitute and appoint my husband, Frank Worden, to be executor of this will, to serve without bond. Should my said husband not survive me, or should he be unable or unwilling to act, then I nominate, constitute and appoint my brother-in-law, William J. Worden, to be such executor, to serve without bond.

THIRD: I direct that all lawful claims against my estate be paid as soon as conveniently may be done after my decease.

FOURTH: All of the rest, residue and remainder of my estate I give, devise and bequeath unto my said husband, Frank Worden, should he survive me and be living thirty days after the date of my decease.

FIFTH: Should my said husband not survive me, or should he not be living thirty days after the date of my decease, then I give, devise and bequeath all of such rest, residue and remainder of my estate unto my son, Ronald E. Worden, now of the age of 15 years.

SIXTH: Said executor shall have the following powers and authority in addition to those provided by law: To hold, manage, care for and protect the estate and the income thereof; to operate and manage any and all business belonging to my estate and any interest therein to the extent of such interest, and to continue to operate the same; to sell, exchange, partition, convey and lease the estate or any part thereof; to borrow money and to pledge, mortgage or hypothecate all or any part of the estate as security therefor; to lend his own funds to the estate for the protection thereof or for any other purpose. Said executor may exercise any and all of such powers or authority without regard to any prescribed statutory procedure, and without petition, order, citation, license, authority or confirmation of any Court.
