28455 INDENTURE OF ACCESS

THIS INDENTURE, made and executed this 17<sup>th</sup> day of December, 1968, by  
and between the State of Oregon, by and through its State Highway Commission, herein-  
after called "State" and Donald C. and Patricia H. Kirkpatrick, hereinafter called  
"Owners";

WHEREAS, State by deed recorded February 21, 1968, as Document 20451, in Book M-68,  
at Page 1361, Deed Records of Klamath County, Oregon, acquired from Owners certain  
property situated in SE $\frac{1}{4}$  of Section 7, Township 39 South, Range 9 East, W.M., Klamath  
County, Oregon, which deed, in part, reserved for the service of Owners' remaining  
property access rights to the Southerly side of the relocated Green Springs Highway  
opposite Engineer's Station 14+50; and

WHEREAS, Owners have requested that their access rights opposite said Station 14+50  
be terminated and that there be substituted therefor access rights to the Southerly side  
of said highway opposite Engineer's Station GS<sup>2</sup> 19+25; and

WHEREAS, State has indicated a willingness to make the access changes requested by  
Owners.

NOW THEREFORE, THIS INDENTURE WITNESSETH, that for and in consideration of the grant  
hereinafter made by State, OWNERS do hereby transfer and relinquish unto State, its  
successors and assigns, their access rights to and from the Southerly side of the relo-  
cated Green Springs Highway opposite said Station 14+50 which was reserved in the above-  
mentioned deed recorded February 21, 1968. Owners further represent and warrant that no  
one, other than Owners, is using or entitled to use the access rights herein relinquished.  
STATE, in consideration of the relinquishment and warranties herein made by Owners, does  
hereby grant and convey unto Owners, their heirs and assigns, access rights to and from  
the Southerly side of said highway, opposite said Station GS<sup>2</sup> 19+25 in a width of 35 feet  
and unrestricted as to use.

Except as modified herein, said deed recorded February 21, 1968, shall remain in  
full force and effect and the rights of access herein granted shall be subject to all

the provisions of said deed, including the frontage road provisions thereof, as fully
