This matter came on to be heard in open court this day. Plaintiff appeared in person and by O. W. Goakey, her attorney. The State of Oregon appeared by its District Attorney for Deschutes County, Oregon. Defendant appeared not, either in person or by attorney. It appearing that defendant has heretofore been declared in default having been entered herein, and that there is on file herein defendant's Waiver of Service wherein defendant waived the service of Summons and Complaint herein; and the Court having heard the testimony introduced on behalf of plaintiff and having filed its Findings of Fact and Conclusions of Law and being fully advised in the premises and of the decree which should be entered herein, now, therefore, it is hereby

ORDERED, ADJUDGED AND DECREED that the marriage contract heretofore existing between plaintiff and defendant shall be terminated and forever dissolved on February 2, 1966, or, if appeal is taken from this decree, then upon the termination of such appeal, whichever is later, without any further action by either party, and it is further

ORDERED, ADJUDGED AND DECREED in case either party to this suit dies prior to the date specified in paragraph hereinbefore stated, to-wit: February 2, 1966, this decree
