SEEK, husband and wife, hereinafter designated the "builder", materials to be and which were used in the construction, alteration and/or repair of that certain building and/or improvement known as a residence or dwelling house located upon certain land situated in the County of Klamath, State of Oregon, and described as follows:

Lot 6, Block 5, Bonanza Original Addition, according to the official plat thereof.

SIGNS FOR CLAIMANT

That at the time claimant commenced to furnish said materials ROSCOE J. SEEK aka R. J. SEEK and SARAH E. SEEK, husband and wife, was the owner or reputed owner of said land and the building and improvements thereon, and had knowledge of, and consented to, the construction, alteration and/or repair of said building and/or improvement, and ROSCOE J. SEEK aka R. J. SEEK and SARAH E. SEEK, husband and wife, is now the owner or reputed owner of the above described land and the building and improvements thereon and had knowledge of, and consented to, the construction, alteration and/or repair of said building and/or improvement.

That the said builder had charge of said construction, alteration and/or repair.

That the contract price and reasonable value of said materials furnished by the claimant as aforesaid was and is the sum of Three Hundred Fifty-nine and 83/100ths --- Dollars lawful money of the United States and there is now due claimant for said materials, after deducting all just credits and offsets, the sum of Two Hundred Thirty-seven and 54/100ths --- Dollars.
