

THIS MORTGAGE, Made this 16 day of January, 1969, by  
Hal F. Coe and Betty M. Coe, husband and wife,  
Mortgagor,  
to M. A. Carter and Jacqueline Carter, husband and wife,

WITNESSETH, That said mortgagor, in consideration of the sum of - - - Four Thousand Seven Hundred Seventy-One and 12/100 - - - (\$ 4,771.12 ) Dollars to the mortgagor paid by the mortgagees, the said mortgagor does hereby grant, bargain, sell and convey unto the said mortgagees as joint tenants with the right of survivorship and not as tenants in common, their assigns and the heirs of the survivor of them, those certain premises situate in the County of - - - Klamath and State of - - - Oregon - - - , and described as follows, to-wit:

Lot 5 in Block 300 of DARROW ADDITION to the City of  
Klamath Falls, Oregon,

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining; together with the rents, issues and profits therefrom and all fixtures now or hereafter placed or installed in or upon said described premises,

TO HAVE AND TO HOLD the same unto the said mortgagees as joint tenants with the right of survivorship and not as tenants in common, and to their assigns and the heirs of the survivor forever.

**This mortgage is intended to secure the payment of one certain promissory note in words and figures substantially as follows:**

Each of the undersigned promises to pay to the order of M. A. Carter and Jacqueline Carter

and upon the death of any of them, then to the order of the survivor of them, at Elmestello, Oregon  
 - - - Four Thousand Seven Hundred Seventy-one and 12/100 - - - DOLLARS,  
 with interest thereon at the rate of 7 1/2 percent per annum from January 20, 1949 until paid, payable in  
monthly installments, at the dates and in the amounts as follows: \$55.00 March 1, 1949 and \$55.00  
on the 1st day of every month thereafter (with right to prepay all or any part at  
any time) until July 1, 1972, at which time payments will be increased to  
\$110.00 per month until the full balance and interest are paid,

with principal and interest, has been paid; if any of said installments is not so paid, the whole sum of both principal and interest shall become immediately due and collectible at the option of the holder of this note. If this note is placed in the hands of an attorney for collection, each of the undersigned promises and agrees to pay the reasonable collection costs of the holder hereof; and if suit is brought hereon, also promises to pay (1) holder's reasonable attorney's fees to be fixed by the trial court and (2) if any appeal is taken from any judgment of the trial court, such further sum as may be fixed by the appellate court, as the holder's reasonable attorney's fees in the appellate court.

It is the intention of the parties hereto that the said promise of not ask.

It is the intention of the parties hereto that the said payees do not take the title hereto as tenants in common but with the right of survivorship, that is: on the death of any of the payees, the right to receive payment of the then unpaid balance of principal and interest shall vest absolutely in the survivor of them.

in construing this mortgage and the said note, the words "survivor" shall include survivors; the words "mortgagee" shall include mortgagees; the singular pronoun shall be taken to mean and include the plural; the masculine; the feminine and the neuter; and all grammatical changes shall be made, and implied to make the provisions hereof apply equally to corporations and to more than one individual; furthermore, the word "mortgages" shall be construed to mean the word "mortgage" above; if all or both of them be living, and if not, then the survivor or survivors of them, because it is the intention of the parties hereto that the said mortgage shall be held by the said mortgagees as joint tenants with the right of survivorship; and not as tenants in common; and that on the death of one, the moneys then unpaid on said note as well as all rights and interests herein given to the mortgagees shall vest forthwith in the survivor or them.

And said mortgagor covenants to and with the mortgagees, and their successors in interest, that he is lawfully seized in fee simple of said

premises and has a valid, unincumbered title thereto. Subject only to first mortgage thereon to First Federal Savings and Loan Association of Klamath Falls, to which this mortgage is second and inferior, and which first mortgage mortgagors will pay as the same becomes due;

and will warrant and forever defend the same against all persons; that he will pay said note(s), principal and interest, according to the terms thereof; that while any part of said note(s) remains unpaid he will pay all taxes, assessments and other charges of every nature which may be levied or assessed against said property, or this mortgage or the note(s) above described, when due and payable and before the same may become delinquent; that he will promptly pay and satisfy any and all liens or encumbrances that are or may hereafter be erected on the premises insured in favor of the mortgagee; that he will keep the buildings now on or which may hereafter be erected on the premises insured in favor of the mortgagee against loss or damage by fire, with extended coverage, in the sum of \$..... **insurable value**.....

in a company or companies acceptable to the mortgagee and will have all policies of insurance on said property made payable to the mortgagee as their interest may appear and will deliver all policies of insurance on said premises to the mortgagee as soon as insured; that he will keep the buildings and improvements on said premises in good repair and will not commit or suffer any waste of said premises.

Now, therefore, if said mortgagor shall keep and perform the covenants herein contained and shall pay said note(s) according to its terms, this conveyance shall be void; but otherwise shall remain in full force as a mortgage to secure the performance of all of said covenants and the payment of said note(s); it being agreed that if the mortgagor shall fail to make any payment or to perform any covenant herein, or if a proceeding of any kind be taken to foreclose any lien on said premises, or any part thereof, the mortgagee shall have the option to declare the whole amount unpaid on said note(s) or on this mortgage at once due and payable, and this mortgage may be foreclosed at any time thereafter. And if the mortgagor shall fail to pay any taxes or charges or any lien, encumbrance or insurance premium as above provided for, the mortgagee may at their option do so, and any payment so made shall be added to and become a part of the debt secured by this mortgage and shall bear interest at the same rate as said note(s), without waiver, however, of any right arising to the mortgagee for breach of covenant; and this mortgage may be foreclosed at any time while the mortgagor neglects to repay any sums so paid by the mortgagee.

In the event of any suit or action being instituted to foreclose this mortgage, the mortgagor agrees to pay all reasonable costs incurred by the mortgagee for title reports and title search, all statutory costs and disbursements and such further sum as the trial court may adjudge reasonable as plaintiff's attorney's fees in such suit or action, and if an appeal is taken from any judgment or decree entered therein mortgagor further promises to pay such sum as the appellate court shall adjudge reasonable as plaintiff's attorney's fees on such appeal, all such sums to be secured by the lien of this mortgage and included in the decree of foreclosure.

In case suit or action is commenced to foreclose this mortgage, the court upon motion of the mortgagee, may appoint a receiver to collect the rents and profits arising out of said premises during the pendency of such foreclosure and apply the same to the payment of the amount due under the mortgage, first deducting all proper charges and expenses attending the execution of said trust.

Each and all of the covenants and agreements herein contained shall apply to, inure to the benefit of and bind the heirs, executors, administrators, successors in interest and assign of said mortgagor and of said mortgagee respectively.

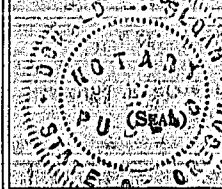
