NOTICE OF LIEN CLAIM

The Department of Employment Commissioner of Oregon hereby claims a lien in the amount of \$335.26 with interest on \$301.62 at the rate of one percent per month, or fraction thereof, until paid, upon:

all buildings, fixtures, furniture, equipment, and other personal property of whatsoever kind and nature owned by Lake Resort Operators, Inc. and situated on the real property known as Lake of the Woods Resort, in Klamath County, Oregon.

Said lien is claimed for a sum equal to unpaid taxes due and payable for the third and fourth calendar quarters of 1968

and \$7.76 interest, with interest on \$301.62 in the amount of \$301.62 taxes at the rate of one percent per month, or fraction thereof, from the 31st day of January, 1969, until paid, and penalty of \$25.88

That written demand for payment of the sum of \$258.75, then due, was made on the defendant on November 6, 1968, and defendant failed to make payment within ten days of said demand;

That because of the failure of defendant to make payment as required by the provisions of section 3 of ORS 657.515, defendant was in default;

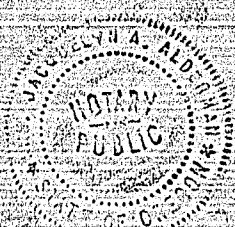
That said monies are now due the Department of Employment Commissioner for which he claims this lien.
