KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated April 4, 1966, executed and delivered by Ernest L. McNeil and Jo Ann McNeil, husband and wife, as grantor and recorded on April 11, 1966, in book M-66 at page 3186 of the Mortgage Records of Klamath County, Oregon, conveying real property situated in said county described as follows:
