And the said party of the first part as United States Marshal for the District of Oregon, does vouch for the right and lawful authority to dispose of the said personal property according to law.

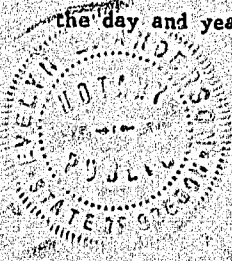
