# NOTICE OF LIEN CLAIM

vs.

The Department of Employment Commissioner of Oregon hereby claims a lien in the amount of \$43.31 with interest on \$38.14 at the rate of one percent per month, or fraction thereof, until paid, upon:

any and all of the real and personal property of whatsoever kind or nature, used or usable in the operation of Ranch Cafe, situated in Klamath County, Oregon, and specifically described as follows:

Said lien is claimed for a sum equal to unpaid taxes due and payable for the Fourth calendar quarter of 1968

in the amount of \$38.14 taxes and \$0.86 interest, with interest on \$38.14 at the rate of one percent per month, or fraction thereof, from the 31st day of March, 1969, until paid, and penalty of \$4.31

That written demand for payment of the sum of \$43.14, then due, was made on the defendant on February 18, 1969, and defendant failed to make payment within ten days of said demand;

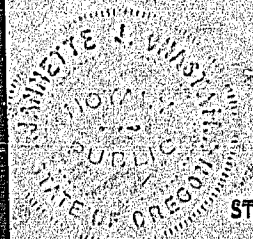
That because of the failure of defendant to make payment as required by the provisions of section 3 of ORS 657.515, defendant was in default;
