

DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated September 24, 1968, executed and delivered by Raymond Lee Daniels and Elizabeth J. Daniels, husband and wife, as grantor and recorded on September 25, 1968, in book M-68 at page 8693 of the Mortgage Records of Klamath County, Oregon, conveying real property situated in said county described as follows:

Beginning at a point which lies N. 1°12' W. a distance of 331.4 feet along the section line and North 88°57' E. a distance of 1084.5 feet from the iron axle which marks the one quarter section corner common to Sections 10 and 11 in Township 39 South, Range 9 E.W.M., and running thence: continuing N. 88°57' E. a distance of 135.0 feet to a point; thence No. 1°12' W. parallel to the section line a distance of 331.4 feet, more or less, to an iron pin in the North line of the S½SW¼ of Section 11; thence South 88°58' W. along the said North line of the S½SW¼ of Section 11, a distance of 135.0 feet to an iron pin; thence South 1°12' E. a distance of 331.4 feet, more or less, to the point of beginning of said tract, in the S½SW¼ of Section 11, Township 39 South, Range 9 East, Willamette Meridian.

There is reserved for road purposes a strip of land 30 feet wide along the Southerly side of said tract, having received from the beneficiary under said trust deed a written request to reconvey, reciting that the obligation secured by said trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deed.

In construing this instrument and whenever the context hereof so requires, the masculine gender includes the feminine and neuter and the singular includes the plural.
