CONSENT AND SUBORDINATION AGREEMENT

WHEREAS, Brooks-Scarlon, Inc., hereinafter called "Brooks," has an interest in the real property hereinafter described by virtue of an easement dated the 17th day of January, 1957, and recorded the 22nd day of January, 1957, in Book 289, Page 277, Deed Records of Klamath County, State of Oregon, and which easement covers the following-described real property situated in the County of Klamath, State of Oregon, to-wit:


A strip of land 100 feet in width traversing the N1/2SE1/4, NEI/4SW1/4 of Section 5; NW1/4SW1/4 of Section 4, all in Township 24 South, Range 9 East, W. M., Klamath County; The said strip being 50 feet in width on each width as much additional width as required for the adequate protection of cuts and fills, said centerline being more particularly described as follows:

Beginning at the NE corner of the NWI/4SW1/4 of Section 4. Township 24 South, Range 9 East, and thence going in a Westerly direction to the intersection with the West Section Line of said Section, said point being 264 feet South of the WI/4 corner of said Section; thence going in a South Westerly direction to the intersection with the North and South Quarter line of Section 5. Township 24 South, Range 9 East, W. M.; said point being approximately 357 feet North of the South East Corner of the NEI/4SWI/4; thence Southerly and Westerly to the intersection with the South line of the NEI/4SWI/4 of said Section 5, said point being approximately 745 feet West of the SE corner of the NEI/4SWI/4.

WHEREAS, Cameron Cliff, hereinafter called the "GRANTOR," has conveyed to the United States of America, acting by and through the Forest Service, U.S.D.A., hereinafter called the "GRANTEE," an easement for the right-of-way purposes over and across said real property by virtue of instrument dated the 5th day of November, 1964, in Book 358, Page 557, Deed Records of Klamath County, State of Oregon.

NOW, THEREFORE, Brooks consents to the above-mentioned conveyance from the granter to the grantee and subordinates its interest in the real property hereinbefore described to the rights of the grantee in and to said real property by virtue of the above-mentioned instrument.
