KNOW ALL MEN BY THESE PRESENTS, That PHILIP LEIDHOLDT and INEZ LEIDHOLDT, Husband and Wife,

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by FRED N. BARLOW and VICTORIA BARLOW,

hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit: Lots 6, 7, 8, 9 and 10, Block "D" of RAILROAD ADDITION to the City of Malin, Klamath County, Oregon. SUBJECT TO: City Lien of City of Malin, if any and Reservations, including the terms and provisions thereof, as set out in deeds from Malin Townsite Company, a corporation, to Philip Leidholdt and Inez Leidholdt, husband and wife, dated Jan. 2, 1945, recorded Feb. 6, 1945, in Volume 173, page 161, also deed dated September 8, 1945, recorded July 8, 1946 in Volume 192, page 38, all in Deed Records of Klamath County, Oregon.

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.

And grantor hereby covenants to and with grantees and the heirs of the survivor and their assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except those above stated,

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 10,500.00. However, the actual consideration consists of or includes other property or value given or promised which is part of the consideration (indicate which).

In construing this deed and where the context so requires, the singular includes the plural, the masculine includes the feminine and the neuter and, generally, all grammatical changes shall be made, assumed and implied to make the provisions hereof apply equally to corporations and to individuals.
