14 to said contract to Assignors herein.

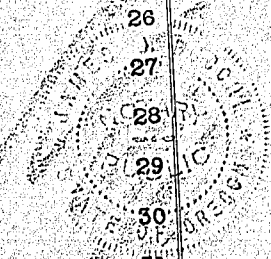
15 And Assignors further, in consideration of the foregoing, hereby bargain,
